Replace tape backup system with Barracuda cloud solution designed to work in conjunction with our current Barracuda devices

We are required to have a disconnected (from the network) backup solution in addition to the networked backup solution.

Tape backup solutions are antiquated, laborious and less dependable than cloud solutions. Their primary attraction is cost savings.

There will be a trade off in cost and man hours.

Currently we pay \$2,200 a year for maintenance on the tape system and spend another \$1,000 a year on tapes. If we move, these costs will go away, and we will see an annual increase of roughly \$15,000 a year above our current budget.

The primary benefits of this move will be realized in dependability and decreased man hours spent maintaining the system.

Currently I spend 3 to 15 minutes a week on the current Barracuda system and it runs and tests very well; very consistent. I spend 3 to 10 hours a week working on the tape system and it is endlessly problematic, and tests are far less consistent.

The lease agreement is a 36-month agreement with annual payments of \$18,376.38.
